

## **privacy Policy [www.tucarreraya.com](http://www.tucarreraya.com)**

AR Associate Counselors , Inc. ( ARAC ) is committed to respecting the privacy of users accessing the website [www.tucarreraya.com](http://www.tucarreraya.com) (the " Web Site" ) , so the information gathered , in order to answer the screening test ARCI career or any other service, such as name , address, telephone and email address is restricted and treated as confidential information. Only the user can access to modify personal data deemed necessary. ARAC does not share or disclose any information, much less information on credit card numbers or confidential relevant information that could cause any harm to our users .

Overall, the information gathered by ARAC refers to the answers to test questions you provide in order to obtain statistics to improve measurement instruments offered through the Web Site. It is possible that our website provides links to third party sites, and because we have no control over them, we encourage you to review the privacy policies of these.

### **Uses of the information collected by ARAC:**

In order to provide you with a wide range of services, the categories of data we collect are:

- Information you provide to us when requesting ARAC services that require a registration process, the applicant must provide us with personal information (name, email address and account password , for example). Similarly when paying for services , credit card details are requested through the secure PayPal page , which is a recognized payment service . Payment information is not archived or saved by ARAC .
- User communications: When you send email or other communications to ARAC , we may retain those communications in order to process your inquiries , respond to your requests and improve our services.
- Other sites: this Privacy Policy applies only to ARAC services on the Website . We have no control over the sites displayed as search results , sites that include applications, products or services of ARAC , or links included in our services. It is possible that these independent sites place their own cookies or other files on your computer, collect data or solicit personal information sent.

ARAC will process personal data only in accordance with the provisions of this Privacy Policy or in additional notifications for specific services . In addition to the above, such purposes include:

- Provide our services to users, including the publication of content and advertising
- Auditing, research and analysis to maintain, protect and improve our services,
- Ensuring the technical functioning of our network
- Protect the rights or property of our users and ARAC's or
- Develop new services.

### **Different Options of Personal Information Collection:**

Every time you access a particular service that requires registration, we ask you to provide personal data. If we use these data for purposes other than those for which it was collected , we will ask for your consent.

If we decide to use personal data for a purpose other than that described in this Privacy Policy or the separate notifications for each service, you will be able to clearly express your opposition. ARAC will not collect or use sensitive information for purposes other than those set out in this policy or specific additional ads without your prior consent.

Most browsers are set to accept cookies , but you can reset your browser to refuse all cookies or to indicate the system at what time it is sent . However, if cookies are disabled , it is possible that some features and services of ARAC do not work properly.

## **Shared Data:**

ARAC only shares personal information with other companies or individuals who are unrelated to ARAC in the following circumstances:

- When we have your consent . We request to provide your consent to share any confidential information.
- We provide such information to our subsidiaries and related entities and other companies or people you trust to carry out the data handling on our behalf. These entities must carry out the processing of data on our instructions and in accordance with this Privacy Policy and shall also take the measures of confidentiality and security we deem appropriate.
- ARAC believes in good faith that access, use, preservation or disclosure of such information is reasonably necessary to ( a ) comply with laws and regulations, judicial proceedings or administrative requirements ; ( b ) enforce applicable Terms of Service , including investigation of potential violations resulting therefrom ; ( c ) detect, prevent or address technical problems or cases of fraud or security by any other means ; or ( d ) protect against imminent harm to the rights, property or safety of ARAC , its users or the public as required or permitted by law.

If ARAC conducts a merger, acquisition, or any form of sale of all or any of its assets, we will post a notice before carrying out the transfer of personal data. We may share with third parties certain aggregated, non- personal data, such as the number of users who searched for a term and the number of people who clicked on a particular advertisement .
